

### INVESTMENT OBJECTIVE

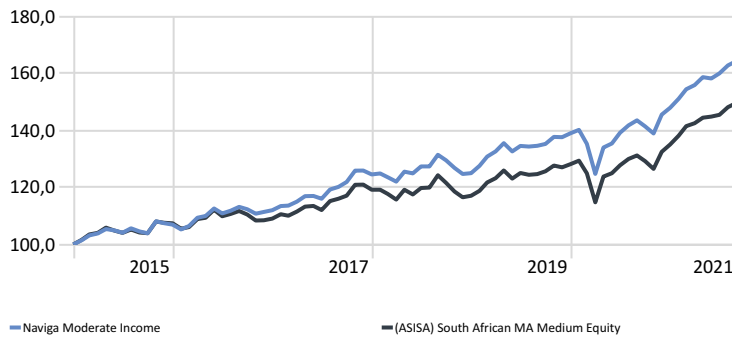

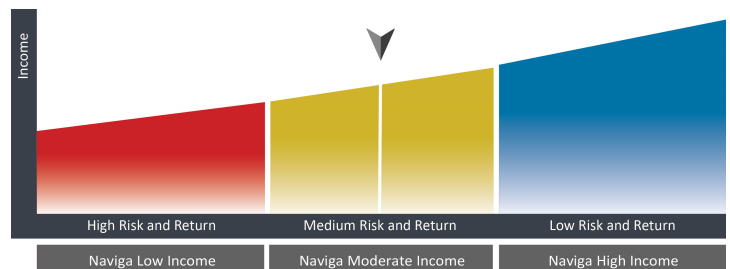

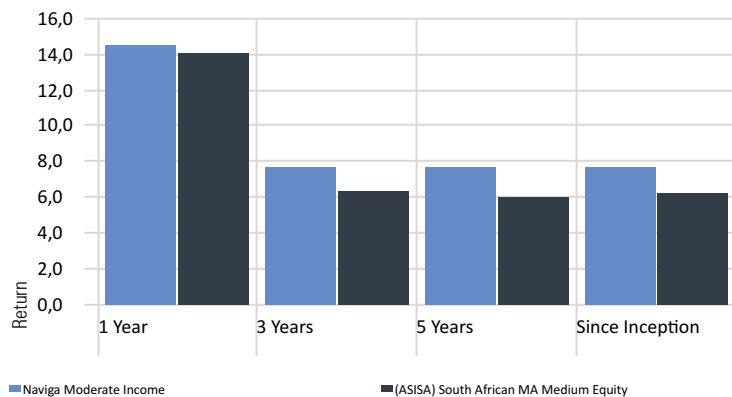

#### Medium | Medium - High

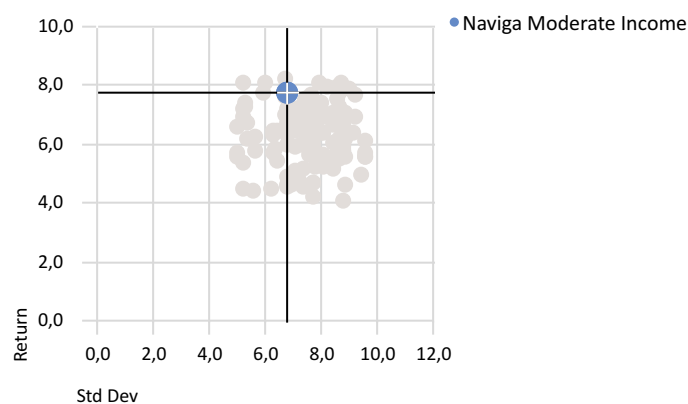

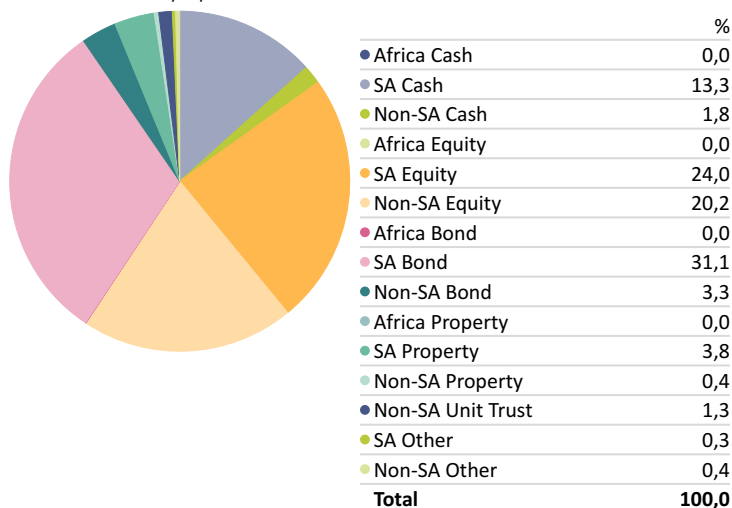

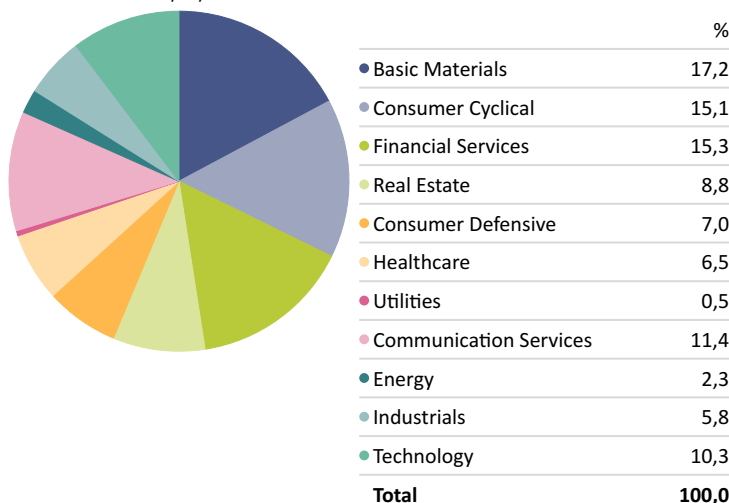
## ASSET ALLOCATION
